6. Preparations for the first session of the Conference of the Parties serving as the meeting of the Parties to the Kyoto Protocol:

² At the fourth session of the Conference of the Parties (COP), it “proved impossible to reach any agreed conclusions or decisions” on this matter (FCCC/CP/1998/16, para. 64) and the item was therefore included in the provisional agenda for the COP at its fifth session in accordance with rule 10 (c) and rule 16 of the draft rules of procedure being applied. II. Proposed organization of the session: overview

1. The tenth session of the Conference of the Parties (COP 10) will open on **Monday, 6 December 2004**. At its first meeting, the COP will take up item 1 of the provisional agenda. The COP is then expected to address a number of procedural and substantive matters under item 2, including the adoption of the agenda and the organization of the work of the session.
2. The COP will meet to discuss agenda items 6 (c), 7, 8 and 9 (c) on **Wednesday, 8 December**.
3. The twenty-first sessions of the Subsidiary Body for Implementation (SBI 21) and the Subsidiary Body for Scientific and Technological Advice (SBSTA 21) will be held in conjunction with COP 10. The subsidiary bodies will be convened after the opening meeting of COP 10. They will finalize as many issues as possible, including matters referred to them by the COP, and develop draft decisions and conclusions for submission to the COP **before their sessions end on Tuesday, 14 December**.
4. The SBSTA will hold an in-session workshop on **Wednesday, 8 December**, on the application of methods and tools, including regional models, for assessing impacts and vulnerability and adaptation, and on the linkages between adaptation and sustainable development. The SBSTA will also hold an in-session workshop on **Thursday, 9 December**, on mitigation technology innovation, deployment and diffusion, including identification of and removal of barriers and on practical opportunities and solutions for mitigation that contribute to sustainable development. In accordance with the conclusions of SBI 20, there will be an in-session workshop on **Saturday, 11 December**, on the organization of the intergovernmental process.
5. The SBI at its twentieth session endorsed the dates of **15 to 17 December 2004 for the high-level segment** of ministers and other heads of delegation. Further information on the **panel discussions** among ministers and other heads of delegations will be made available following consultations with the Bureau, and will be included in an addendum to this document.
6. COP 10 will close on **Friday, 17 December**, following the adoption of decisions and conclusions.
7. Given the heavy workload of the session, provision has been made to hold **two simultaneous meetings**, with full interpretation facilities, in the mornings and afternoons of the entire period, including Saturday, 11 December. A **tentative schedule of meetings** is contained in annex I, and the list of documents in annex II.
8. The documents for each item of the provisional agenda are listed in a text box below the corresponding annotation. Information can also be found on the secretariat web site at <http://unfccc.int>.

49. *Background:* Article 4, paragraph 2 (d), provides that a second review of the adequacy of Article 4, paragraph 2 (a) and (b), shall take place not later than 31 December 1998. At COP 4, it

“proved impossible to reach any agreed conclusions or decisions” on this matter.⁶ During the consideration of the provisional agenda of COP 5, the Group of 77 and China proposed amending the item to: “Review of the adequacy of implementation of Article 4, paragraph 2 (a) and (b), of the Convention”. There was no agreement, and the COP adopted the agenda of the session with the item held in abeyance. At every subsequent COP session, the item has been included in the provisional agenda with a footnote reflecting the amendment proposed by the Group of 77 and China at COP 5, the agenda has been adopted with the item held in abeyance, and the President has undertaken consultations on the matter and reported back at a later session.

50. *Action:* The COP may wish to address this matter in the light of the above-mentioned reports. The President may wish to conduct informal consultations with a view to concluding this item.

At COP 9, Parties were unable to reach a conclusion on the matter and decided to include this item in the provisional agenda for COP 10, accompanied by an appropriate explanatory footnote.⁸

54. *Action:* The COP may wish to refer this item to the SBSTA for its consideration and for recommendation of draft decisions or conclusions for adoption by the COP.

(c) Matters relating to Article 6 of the Kyoto Protocol: preparatory work

55. *Background:* In response to decision 16/CP.7, which foresees preparatory work for the implementation of activities under Article 6 of the Kyoto Protocol, the secretariat convened the First UNFCCC Workshop on the Implementation of Article 6 Projects under the Kyoto Protocol (26–27 May 2004, Moscow, Russian Federation).

Report of the Executive Board of the clean development mechanism**61. *Background:* The report provides information on progress made in implementation of the CDM during its third year of operation. Such progress relates to advances in the process leading to the registration of CDM project activities, notably regarding the approval of methodologies for baselines and monitoring, and the accreditation and provisional designation of operational entities. The development of the registry is also given prominence. The report also provides information on measures taken to ensure the transparent functioning of the CDM and on modalities for attendance by observers at meetings of the CDM Executive Board, as well as information on administrative expenses and resources relating to the operation of the CDM. The report recommends decisions for adoption by the COP at its tenth session, inter alia, with respect to the designation of operational entities.62. *Action:* The COP will be invited to take note of the report and consider a draft decision.

8. Inputs from the Conference of the Parties to other intergovernmental meetings(a) International conference for the 10-year review of implementation of the Barbados Programme of Action63. *Background:* The United Nations General Assembly, at its fifty-seventh session,⁹ requested all United Nations bodies and specialized agencies and other relevant intergovernmental agencies and organizations to participate actively in the 10-year review of progress in the implementation of the

Barbados Programme of Action (BPOA). At the third round-table discussion of COP 9, several Parties requested that input be provided to the ongoing review of the BPOA.¹⁰ The conference will be held in Mauritius from 10 to 14 January 2005.

64. *Action:* The COP will be invited to note the upcoming international meeting and decide whether it wishes to provide input to the 10-year review of the BPOA.

(b) World Conference on Disaster Reduction

65. *Background:* The United Nations General Assembly, at its fifty-eighth session,¹¹ decided to convene a World Conference on Disaster Reduction in 2005, and invited Member States, all United Nations bodies and specialized agencies and other relevant intergovernmental agencies and organizations to participate actively in the conference. The first announcement of the conference makes explicit reference to possible contributions from UNFCCC and COP 10. The Conference will be held at Kobe, Hyogo, Japan, from 18 to 22 January 2005.

66. *Action:* The COP will be invited to consider this item and decide whether it wishes to provide input to the World Conference on Disaster Reduction.

(c) Process for providing input to the fourteenth session of the Commission on Sustainable Development (CSD 14)

67. *Background:* The Commission on Sustainable Development, at its eleventh session, adopted a multi-year programme of work in which the thematic cluster of energy for sustainable development, industrial development, air pollution/atmosphere, and climate change will be considered in the 2006–2007 cycle, including a review session in the first year of the cycle and a policy session in the second year. The Commission has invited relevant United Nations agencies, within their mandates, to inform it of their activities designed to further the implementation of Agenda 21, the Programme for the Further Implementation of Agenda 21 and the Johannesburg Plan of Implementation.

68. *Action:* The COP will be invited to consider this item and provide guidance on the process to be adopted for providing input to the Commission on Sustainable Development.

71. *Background:* See the SBI 21 provisional agenda and annotations (FCCC/SBI/2004/11).

72. *Action:* The COP will be invited to refer this item to the SBI for its consideration and for recommendation of a draft decision for adoption by the COP.

(c) Procedure for the appointment of an Executive Secretary

73. *Background:* The procedure for the appointment of an Executive Secretary was included in the provisional agenda of COP 8 at the request of the Bureau. The COP was invited to consider the matter, taking into account decision 14/CP.1, and determine any appropriate action. Under decision 14/CP.1 on the institutional linkage of the Convention secretariat to the United Nations, the COP requested the Secretary-General to appoint, after consultation with the Conference of the Parties through its Bureau, the head of the Convention secretariat, with the title of Executive Secretary. At COP 8, the President was not in a position to draw conclusions on the matter due to time constraints at the session. The COP noted that the issue would be considered at a future session.

74. *Action:* The COP may wish to invite the President to undertake consultations on the procedure and report to the COP at its tenth session on the outcome.

10. High-level segment: the 10th anniversary of the entry into force of the Convention

75. The SBI, at its twentieth session, recognized that the year 2004 will mark the 10th anniversary of the entry into force of the Convention and recommended that the 10th anniversary serve as the central theme for COP 10. It considered arrangements for COP 10 in the event that the Kyoto Protocol had not yet entered into force and endorsed the dates of 15–17 December for the high-level segment to be attended by ministers and other heads of delegation. The SBI also recommended that panel discussions be the mode for exchanges during the high-level segment; that panels would consist of ministers and other heads of delegation; that panel members would initiate an interactive dialogue with other ministers and heads of delegation; that there should be balanced representation among panel members, taking into account geographical representation and diversity of points of view; and that the high-level segment should also provide an opportunity, on request, for statements in the opening ceremony, but that Parties will be expected to contribute mainly through their participation in the panel discussions.

76. The SBI recognized that two panels may need to be held in parallel and recommended that the panels have the following themes:

- The Convention after 10 years: accomplishments and future challenges
- Impacts of climate change, adaptation measures and sustainable development
- Technology and climate change
- Mitigation of climate change: policies and their impacts.

77. Information on the ministerial panel discussions will be made available after further consideration by the Bureau and the Host Government, and will be included in an addendum to this document. Information on participation by heads of United Nations bodies and specialized agencies in the high-level segment will also be made available.

11. Statements by observer organizations

78. Representatives of intergovernmental organizations and non-governmental organizations will be invited to address the COP. Further information will be made available.

12. Other matters

79. Any other matters for the attention of the COP will be taken up under this item.

13. Conclusion of the session

(a) Adoption of the report of the Conference on its tenth session

80. *Background:* A draft report on the work of the session will be prepared for adoption by the COP at the end of the session.

81. *Action:* The COP will be invited to adopt the draft report and authorize the Rapporteur to complete the report after the session under the guidance of the President and with the assistance of the secretariat.

(b) Closure of the session

82. The President will declare the session closed.
