### **Information on the high-level segment**

#### **Opening**

*The high-level segment will be opened by H.E. Mr. Miklós Persányi, President of COP 9, at 10 a.m. Following the opening ceremony, statements will be made by heads of United Nations bodies and specialized agencies, and intergovernmental and non-governmental organizations.*

#### **Round-table discussions**

*At the third meeting of the Conference of the Parties on Thursday, 4 December 2003, the President informed Parties of the preparations for the round-table discussions to be held during the high-level segment. The President stated that his main aim during the round-table discussions is to establish an atmosphere of constructive, open and interactive dialogue. Together with the co-chairs, he would like to provide an equal opportunity for all Parties to participate.*

- (1) *Climate change, adaptation, mitigation and sustainable development

*The President will open each round-table discussion and introduce the co-chairs, who will make brief introductory remarks. The President will invite “lead-off” speakers from Annex I and non-Annex I Parties. The discussion will then be opened for Parties to make their contribution. The President has written to ministers and other heads of delegation informing them of the round-table discussion in which their participation would be assured. Parties may also make statements on behalf of “Groups”. There may also be opportunities for spontaneous contributions, to allow flexibility for Parties to join the discussion at any moment. The President and the co-chairs will request the understanding of Parties on time limitations for interventions, which ideally should not exceed three–four minutes for each speaker.*

*At the end of each round-table discussion, the co-chairs will provide an “impressionistic wrap-up”. The President will issue, under his responsibility, a summary of all the round-table discussions, for inclusion in the report of COP 9, on Friday, 12 December 2003.*

*The round-table discussions will take place in Plenary I. There will be one seat at the table for the Head of delegation, and one seat behind for an adviser. Additional seating will be available at the sides and back of the room. The round-table discussions will be broadcast live on CCTV and webcast.*



### Getting there: tackling transport emissions

This is multi-stakeholder, high-level event on “techno-fixes” and “lifestyle fixes”, as options for reversing the trend in transport emissions. The initiative provides an opportunity for the key stakeholder groups in the climate change process to work together on a topic of mutual interest and provide useful inputs on an issue of key importance to the objective of the Convention, during COP 9. The topic of transport was chosen in view of the current, and projected future, critical role of transport as a major contributor to greenhouse gas emissions in Annex I Parties, and its growing importance in non-Annex I Parties. The event is a collaborative effort between the Association des Constructeurs Européens d'Automobiles, CAN International, Climate Alliance, the International Chamber of Commerce, the European Federation for Transport and Environment, the International Institute for Sustainable Development, the World Business Council for Sustainable Development and the Wuppertal Institute. This event will be moderated by the Rt. Hon. Simon Upton, Chair, Round Table on Sustainable Development, Organisation for Economic Co-operation and Development. All participants are invited to come and take part in this lively discussion, which will take place from 1.15 p.m. to 2.45 p.m. in Plenary II.
